Self-Insured Entity is defined as an organization that is self-insured for group health care and/or workers' compensation or is a captive insurance company/risk retention group. This also includes employers considering self-insurance/captive insurance. Self-insurance industry service providers including but not limited to, TPAs, MGUs, & captive management companies do not qualify for this registration rate even if their organization is self-insured. Registrations are screened and those submitted by service providers selecting the employer rate will not be processed.

INDUSTRY SERVICE PROVIDER

Industry service provider is defined as any organization that provides a product or service to the self-insured, fully insured or alternative risk transfer marketplace. This includes, but is not limited to TPAs, MGUs, and captive management companies.
